Yes, it is possible to complete all of the DRE requirements for license renewal by following the Five steps below:

1. Enroll in the DRE-approved correspondence courses "Current Law of California – Part A and B". Part A = 18 hours of Consumer Protection and Part B = 15 hours of Consumer Protection.
2. At the same time enroll in "Ethics", "Trust Funds", "Fair Housing", "Agency" and "Risk Management". Commonly called the "Five Required". Each of these correspondence courses is approved for 3 hours of renewal credit.
3. Completion all open-book Assessment Exercises and return answer sheets to the school before Final Exams.
4. Attend the Orientation and Closed-Book exam session on the Five Required on date and location checked below.
5. The testing on "Current Law of California – Part A and B" is completed by a proctor of your selection. Simply email to the school the name and email address on your proctor and the tests will be emailed. Proctor can not related by blood or marriage or any other relationship that may prejudice the ability to administer the exams. State law limits the number on credit hours to 15 in any 24 hour period. Testing on Part A and B require three day minimum.
